# WELCOME MESSAGES

## CHAIRPERSON JOHN LIDDICOAT



**W**elcome to the 2017-18 Annual report of the Apprentice Employment Network NSW ACT, a year in which the Group Training sector had a profound influence over the careers pathway and skills shortage discussion.

The question of the value and credibility of an Australian Apprenticeship as a pathway to employment success ramped up to a 'mainstream' discussion across media, politics and industry. Critically, this is now building into a positive conversation within schools, parents and young people - but achieving lasting

changes in perceptions of VET pathways will require consistent message and ongoing work right across the sector.

The number of apprentices employed across the AEN NSW ACT membership is growing, and Group Training companies are leading the charge to meet the NSW Government's target of 65% completion rates with the statistical variance to those employed 'direct' broadening. These facts are driving an overdue resurgence of support for members at all levels of Government.

The work of the AEN NSW ACT, and most notably by Jason Sultana (Executive Officer) has been instrumental in informing the discussion and driving initiative into the sector for members. In addition to delivering another sold out conference, and gala awards event the AEN NSW ACT has:

- » Run a multifaceted media awareness campaign
- » Established new web presence
- » Represented the Group Training sector at countless events & forums
- » Delivering a new funded School Based training & Employment program in the ACT

With initiatives such as the "fee free Apprenticeships" launched in NSW it is clear that the current government is proactive in its approach to stimulating demand for apprentices whilst removing perceived barriers to commencement for young people across the state. A number of 'key initiatives' reflecting these same goals we presented to Deputy Premier John Barilaro during the year and his 'in principal support' is indicative of the collaborative approach of the AEN NSW ACT and NSW Government.

Disappointingly, the issue of excessive workers compensation premiums remains a debilitating impediment to growth in numbers of employed traditional trades apprenticeships. Despite the obvious desire to grow numbers the NSW Government has failed to act to protect our members from the significant risks of the premium calculations currently in place. I would like to recognize the Executive Officer for his tireless effort to bring this matter to a resolution and assure members of the deep and ongoing commitment of the AEN NSW ACT to bringing about systemic change.

I congratulate the Executive Officer, Board and committee members for your dedication to and focus on responsible financial management, collaboration and industry advancement and look forward to another exciting year for the AEN ACT NSW.



# INDUSTRY & COMMUNITY ENGAGEMENT

## Political engagement

AEN NSW ACT has held a number of meetings with both sides of government. Meetings were held to raise the profile of the Group Training Industry but address issues that included the Workers Compensation Premiums for GTOs.

## TAFE NSW Partnership

TAFE NSW and AEN NSW ACT signed a Memorandum of Understanding to work better together to generate new opportunities for apprenticeships and traineeships in NSW.

## Infrastructure Skills Legacy Program

AEN NSW ACT is working closing with the NSW Government to identify opportunities for Group Training to be involved with the major infrastructure projects in NSW.

## Duke of Edinburgh Awards

AEN NSW ACT is a founding member of the Duke of Edinburgh Employer Program where participants are encouraged to promote their participation in program. The initiative encourages the employers to recognise the skills of leadership and transformational learning with these participants.

## Southern Cross Catholic Vocational College

AEN NSW ACT continues to be a member of its industry advisor group. The college was named the 2015 Australian Training Awards – School Pathways to VET winner.

## Multi Industry Pilot Project

Funded Federally through the Apprenticeship Employment Network in Victoria, the Multi Industry Pre-Apprentice project aims to provide participants with the opportunity to have a “hands on” trial of 3-4 different industries during a course. The project also supports host employers as they can engage with a number of young participants through the project to find the best possible “fit” for their business. AEN NSW ACT supports the project by sitting on its industry advisory group.

## SafeWork NSW Young Worker Mental Health Collaboration

AEN NSW ACT has been an active member of a working group focusing on the Mental Health of young workers in NSW. Coordinated by SafeWork NSW the group meets quarterly to tackle the relevant issues.

## NSW VET Consultative Committee

AEN NSW ACT is a member of the NSW Department of Industry Vocational Training Consultative Committee. This is made of key VET industry representatives and meets quarterly to discuss matters around VET in NSW.

## Workers Compensation Premiums for GTOs

Members of AEN NSW ACT continue to be hit hard around Workers Compensations Premiums costs in NSW. An active ongoing campaign is ongoing with the NSW Government to make changes to ensure GTOs are not being disadvantaged under the new scheme.

## Sponsorship of the NSW & ACT Training Awards

AEN NSW ACT continues to be a sponsor at both the NSW and ACT Training Awards.

## Media

Throughout the 2017-18 year AEN NSW ACT has been active in the media with radio interviews on stations 2GB and 2UE. In the last 12 months, we have developed a strong working partnership with News Corp Australia with stories appearing in their publications and the support of speakers at the 2018 Skills Conference.

## Career/Apprenticeship Expos

As part of the promotion of Pre Apprenticeship Courses, AEN NSW ACT was actively involved in over 30 Career/Apprenticeship Expos in the last 12 months.

## Inquiry into the Extent, Nature and Consequence of Insecure Work in the ACT

AEN NSW ACT has been active in this inquiry for submissions and hearing representations. The key message is to ensure Group Training is not treated the same as Labour Hire firms and be required to be "licenced" to operate in the ACT.

## ACT Apprentice and Young Workers Safety Advisory Committee

AEN NSW ACT has been involved in the advisory committee looking at the safety of Apprentices and young workers across various industries.


